**SECOND INTERIM POST CONFIRMATION FEE APPLICATION FOR ALLOWANCE
AND PAYMENT OF COMPENSATION OF LESLIE ROY GROSSMAN AS EXPERT
TO CHAPTER 11 LIQUIDATING TRUSTEE**

Leslie Roy Grossman (“*Mr. Grossman*” or “*Applicant*”), having been approved by this Court as expert consultant for Chapter 11 Liquidating Trustee, Barry E. Mukamal (“*Trustee*”), applies for interim compensation for fees for services rendered in this Chapter 11 proceeding between July 1, 2016 through October 31, 2016. This application is filed pursuant to 11 U.S.C. § 331 and Bankruptcy Rule 2016, and meets all of the requirements set forth in the Guidelines incorporated in Local Rule 2016-1(B)(1). In support of the application, Mr. Grossman states as follows:

1. On November 30, 2009, Palm Beach Finance Partners, L.P. (the “*Debtor*”) filed its Voluntary Petition for relief under chapter 11 of the United States Bankruptcy Code [ECF No. 1]. On December 1, 2009, this case was jointly administered with the estate of *In re Palm Beach Finance II, L.P.*, Case No. 09-36396-PGH [ECF No. 19].

2. On January 28, 2010, the Court entered the Agreed Order Directing Appointment of Chapter 11 Trustee and denying the United States Trustee's Motion to Convert Cases to Cases under Chapter 7 [ECF No. 100].

3. On January 29, 2010, the United States Trustee appointed the Liquidating Trustee as Trustee in both estates [ECF No. 107].

4. On February 24, 2016, this Court entered an Order [ECF No. 2850] authorizing the Liquidating Trustee's retention of Leslie Roy Grossman as expert consultant to the Liquidating Trustee, *nunc pro tunc* to February 5, 2016.

5. At the confirmation hearing held on October 19, 2010, the Court confirmed the *Second Amended Joint Plan of Liquidation of Barry Mukamal, as Chapter 11 Trustee of Palm Beach Finance Partners, L.P. and Palm Beach Finance II, L.P. and Geoffrey Varga, as Joint Official Liquidator of Palm Beach Offshore, Ltd., and Palm Beach Offshore II, Ltd.*, dated September 3, 2010 [ECF No. 245] (the "**Plan**") in the above referenced jointly administered bankruptcy proceeding. The Plan defines Confirmation Date as "the date on which the Bankruptcy Court enters the Confirmation Order on its docket". The Order Confirming Second Amended Joint Liquidating Chapter 11 Plan [ECF No. 444] (the "**Confirmation Order**") was entered on the Court's docket on October 21, 2010.

6. Article 7 of the Plan provides:

7.1.4 *PBF Liquidating Trust Management.* Barry Mukamal shall be PBF Liquidating Trustee with the power and authority set forth in the PBF Liquidating Trust Agreement.

7.1.5 *PBF Liquidating Trust Structure.* As more fully set forth in the PBF Liquidating Trust Agreement, the PBF Liquidating Trustee shall oversee and direct the PBF Liquidating Trust's operations and activities, including the retention of counsel.

7.1.7 *PBF II Liquidating Trust Monitor.* Geoffrey Varga, as Joint Official Liquidator for Offshore Funds shall be the PBF II Liquidating Trust Monitor with the power and authority set forth in the PBF II Liquidating Trust Agreement.

7.1.11 *Compensation of Professionals Retained by the Liquidating Trustees and the PBF II Liquidating Trust Monitor.* Professionals retained by the PBF II Liquidating Trust Monitor and the Liquidating Trustee shall be entitled to monthly interim compensation for fees and expenses incurred in carrying out their duties consistent with the Plan and the Liquidating Trust Agreements; provided, however, that the PBF II Liquidating Trust Monitor or the Liquidating Trustee shall provide to the other, and the United States Trustee, notice of such requested fees and expenses on a monthly basis. Following such notice, if no objections to the fees and expenses set forth in the monthly statement are received in writing within 10 business days, 100% of such professional's fees and expenses shall be paid. Notice of objections to such fees and expenses shall be made via e-mail and/or facsimile. If objections to the fees and expenses are made and cannot be resolved, such objections will be heard and resolved by the Bankruptcy Court. Any such fees and expenses shall be payable from the Trust Asset of the Liquidating Trusts. The PBF II Liquidating Trust Monitor and the Liquidating Trustee shall, no less frequently than once every four (4) months, submit applications to the Bankruptcy Court for final approval of reimbursement of fees and expenses paid to their professionals.

7. This application is submitted for the allowance and payment to Mr. Grossman in the total amount of \$45,100 for fees and for the reimbursement of expenses in the amount of \$960.43 incurred between July 1, 2016 and October 31, 2016.

8. All of the services rendered by Applicant were performed for and on behalf of the Liquidating Trustee.

I. SUMMARY OF SERVICES RENDERED

9. Mr. Grossman rendered varied services as experts on behalf of the Liquidating Trustee for the period of time from July 1, 2016 through October 31, 2016. Applicant is requesting \$45,100 in professional fees for services rendered. Mr. Grossman logged a total of 90.2 hours during the time period for which fees were required in this fee application.

10. Mr. Grossman devoted 90.2 hours, for a total of \$45,100, towards the review of documents and other case materials in order to perform certain analyses and independent evaluation relating to certain commercial lending and related issues and litigation.

II. REQUEST FOR COMPENSATION

11. Pursuant to the decisions of the United States Court of Appeals for the Fifth Circuit in In re First Colonial Corp. of America, 544 F.2d 1291 (5th Cir. 1977); and In re Johnson v. Georgia Highway Express, Inc., 488 F.2d 714 (5th Cir. 1974), the applicant requests that this Court consider the following factors in determining the amount of compensation that is reasonable for the applicant's services in this case.

III. TIME AND LABOR REQUIRED

12. The transcribed time records and details of services rendered by Applicant are attached hereto as Exhibit 3. Mr. Grossman has devoted 90.2 hours in time in providing services to the Liquidating Trustee between July 1, 2016 through October 31, 2016.

13. The exhibits attached to this application, pursuant to the Guidelines, are:
Exhibits "1-A" and "1-B" - Summary of Professional and Paraprofessional Time
Exhibit "2" - Summary of Requested Reimbursement of Expenses for this Time
Period Only.

Exhibit "3" - The applicant's complete time records, in chronological order, by activity code category (if applicable), for the time period covered by this application. The requested fees are itemized to the tenth of an hour.

Exhibit "4" - Fee Application Summary Chart.

14. Mr. Grossman records the time expended in the rendition of professional services for the Liquidating Trustee by recording a detailed description of such professional services rendered.

IV. NOVELTY AND DIFFICULTY OF THE ISSUES AND QUESTIONS PRESENTED

15. The Liquidating Trustee retained Mr. Grossman as an advisor providing consulting services and possible expert testifying services in contested matters or one or more adversary proceedings commenced by the Liquidating Trustee on issues relating to litigation and commercial lending-related issues, as well as other related or similar analyses that the Liquidating Trustee deems necessary.

V. SKILL REQUISITE TO PERFORM THE LEGAL SERVICES PROPERLY

16. Mr. Grossman has the requisite experience, seniority and skills necessary to effectively and efficiently meet the requirements of the tasks required. Mr. Grossman believes he has demonstrated the requisite, substantial expertise to skillfully provide the services required.

VI. PRECLUSION FROM OTHER EMPLOYMENT

17. Though Mr. Grossman has devoted time as consultant for the Liquidating Trustee as more fully set forth in Exhibit 3, Mr. Grossman has not been forced to decline other matters as a result of accepting this employment.

VII. CUSTOMARY FEE

18. The hourly rate charged is Mr. Grossman's customary fee for services of the type rendered herein.

**VIII. TIME LIMITATIONS IMPOSED BY THE CLIENT
OR THE CIRCUMSTANCES**

19. Mr. Grossman has not been required to expend considerable time within short periods.

IX. THE EXPERIENCE, REPUTATION AND ABILITY OF THE PROFESSIONALS

20. Applicant has substantial experience in the type of services required under this engagement. The quality of work performed by Mr. Grossman in this proceeding attests to the his

experience, reputation and ability.

21. A copy of Mr. Grossman's resume is attached to the Liquidating Trustee's Application to Employ Leslie Roy Grossman [ECF No. 2841], and is incorporated herein by reference.

X. THE UNDESIRABILITY OF THE CASE

22. Mr. Grossman does not deem these cases to be undesirable and is honored to have been retained by the Liquidating Trustee.

XI. APPLICABLE LEGAL STANDARD

23. The amount requested by Applicant is reasonable in terms of awards in cases of similar magnitude and complexity. The compensation which Mr. Grossman is requesting comports with the mandate of the Bankruptcy Code, which directs that services be evaluated in light of comparable services performed in non-bankruptcy cases in the community. The fees requested by Mr. Grossman in the amount of \$45,100 for 90.2 hours of services is entirely appropriate.

24. Applicant considers the reasonable value of services rendered to this estate to be not less than \$45,100 for services rendered for the Fee Period.

XII. ALLOCATION BETWEEN DEBTORS' ESTATES

25. The Liquidating Trustee requests that 18% of the fee awarded be allocated to Palm Beach Finance Partners, L.P. ("**PBF**") and 82% of the fee awarded be allocated to Palm Beach Finance II, L.P. ("**PBF II**"). Section 1.76, entitled "Pro Rata Allocation Formula," of the Second Amended Joint Plan of Liquidation dated September 3, 2010 [ECF No. 245] provides for a *pro rata* allocation formula derived from the Compiled Financial Statements, dated April 30, 2008, for each of the Debtors by Kaufman Rossin & Co. The data contained therein supports an 18%/82% allocation between PBF and PBF II, respectively, based upon the total assets of each entity as of the

date of such compilations. Based on the circumstances and since the services provided by Applicant were performed on behalf of and benefitted both estates, the Liquidating Trustee believes that this formula is the proper methodology to allocate certain fees and expenses between the two estates, as indicated below:

Estate / Percentage	Fees	Costs

TOTAL FEES AND COSTS:	\$45,100.00	\$960.43

WHEREFORE, Leslie Roy Grossman respectfully requests that he be allowed the full compensation sought under this application. Mr. Grossman requests this Court to award a total of \$45,100 for fees and \$960.43 for expenses incurred between July 1, 2016 and October 31, 2016, approve the allocation of fees between the estates, and for such other and further relief this Court deems just and proper.
