Fee Application

Nicholas B. Scheiner, Esq. (“**Mr. Scheiner**”), having been approved by this Court as local counsel in Minnesota for the Chapter 11 Liquidating Trustee, Barry E. Mukamal (“**Trustee**”), applies for allowance of final compensation for professional services rendered and reimbursement of the necessary expenses paid or incurred by applicant in this Chapter 11 proceeding between August 18, 2025 through October 31, 2025. This application is filed pursuant to 11 U.S.C. §§ 330 and 331 and Bankruptcy Rule 2016, and meets all of the requirements set forth in the Guidelines incorporated in Local Rule 2016-1(B)(1). The exhibits attached to this application, pursuant to the Guidelines, are:

Exhibits “1” - Fee Application Summary Chart;

Exhibit “2A” and “2B” - Summary of Professional and Paraprofessional Time;

Exhibit “3” – Summary of Requested Reimbursements of Expenses; and

Exhibit “4” – The applicant's complete time records, in chronological order, by activity code category, for the time period covered by this application. The requested fees are itemized to the tenth of an hour.

Background

1. On November 30, 2009, Palm Beach Finance Partners, L.P. (together with Palm Beach Finance II, L.P., the “**Debtors**”) filed its Voluntary Petition for relief under chapter 11 of the United States Bankruptcy Code [Dkt No. 1]. On December 1, 2009, this case was jointly administered with the estate of *In re: Palm Beach Finance II, L.P.*, Case No. 09-36396-PGH [Dkt No. 19].

2. On January 28, 2010, the Court entered the Agreed Order Directing Appointment of Chapter 11 Trustee and denying the United States Trustee’s Motion to Convert Cases to Cases under Chapter 7 [Dkt No. 100].

3. On January 29, 2010, the United States Trustee appointed the Liquidating Trustee as Trustee in both estates [Dkt No. 107].

4. On August 21, 2025, the Trustee filed his Application for Employment of Nicholas B. Scheiner, Esq., and Greene Espel, PLLP, (“*Greene Espel*”) as Local Counsel in Minnesota [Dkt No. 4031], approved on September 26, 2025 [Dkt No. 4047].

5. At the confirmation hearing held on October 19, 2010, the Court confirmed the Second Amended Joint Plan of Liquidation of Barry Mukamal, as Chapter 11 Trustee of Palm Beach Finance Partners, L.P. and Palm Beach Finance II, L.P. and Geoffrey Varga, as Joint Official Liquidator of Palm Beach Offshore, Ltd. and Palm Beach Offshore II, Ltd., dated September 3, 2010 [Dkt No. 245] (“*Plan*”) in the above referenced jointly administered bankruptcy proceeding. The Plan defines Confirmation Date as “the date on which the Bankruptcy Court enters the Confirmation Order on its docket.” The Order Confirming Second Amended Joint Liquidating Chapter 11 Plan [Dkt No. 444] (“*Confirmation Order*”) was entered on the Court’s docket on October 21, 2010.

6. Article 7 of the Plan provides in pertinent part:

7.1.4 *PBF Liquidating Trust Management.* Barry Mukamal shall be PBF Liquidating Trustee with the power and authority set forth in the PBF Liquidating Trust Agreement.

7.1.5 *PBF Liquidating Trust Structure.* As more fully set forth in the PBF Liquidating Trust Agreement, the PBF Liquidating Trustee shall oversee and direct the PBF Liquidating Trust’s operations and activities, including the retention of counsel.

7.1.7 *PBF II Liquidating Trust Monitor.* Geoffrey Varga, as Joint Official Liquidator for Offshore Funds shall be the PBF II Liquidating Trust Monitor with the power and authority set forth in the PBF II Liquidating Trust Agreement.

7.1.11 *Compensation of Professionals Retained by the Liquidating Trustees and the PBF II Liquidating Trust Monitor.* Professionals retained

by the PBF II Liquidating Trust Monitor and the Liquidating Trustee shall be entitled to monthly interim compensation for fees and expenses incurred in carrying out their duties consistent with the Plan and the Liquidating Trust Agreements; provided, however, that the PBF II Liquidating Trust Monitor or the Liquidating Trustee shall provide to the other, and the United States Trustee, notice of such requested fees and expenses on a monthly basis. Following such notice, if no objections to the fees and expenses set forth in the monthly statement are received in writing within 10 business days, 100% of such professional's fees and expenses shall be paid. Notice of objections to such fees and expenses shall be made via e-mail and/or facsimile. If objections to the fees and expenses are made and cannot be resolved, such objections will be heard and resolved by the Bankruptcy Court. Any such fees and expenses shall be payable from the Trust Asset of the Liquidating Trusts. The PBF II Liquidating Trust Monitor and the Liquidating Trustee shall, no less frequently than once every four (4) months, submit applications to the Bankruptcy Court for final approval of reimbursement of fees and expenses paid to their professionals.

7. This application is submitted for the allowance and payment to Nicholas B. Scheiner and Greene Espel in the amount of \$4,695.00 for fees and \$122.76 costs incurred between September 24, 2025 and October 31, 2025, for a total request of \$4,817.76.

8. All of the services rendered by Mr. Scheiner and Greene Espel were performed for and on behalf of the Trustee.

Summary of Services Rendered

9. Mr. Scheiner serves as local counsel in Minnesota for the Trustee in connection with the following cases pending in the United States Bankruptcy Court, District of Minnesota: *In re Petters Company, Inc.* (Case No. 08-45257); *In re Petters Group Worldwide, LLC* (Case No. 08-45258); *In re PC Funding, LLC* (Case No. 08-45326); *In re Thousand Lakes, LLC* (Case No. 08-45327); *In re SPF Funding, LLC* (Case No. 08-45328); *In re PL Ltd., Inc.* (Case No. 08-45329); *In re Edge One, LLC* (Case No. 08-45330); *In re MGC Finance, Inc.* (Case No. 08-45331); *In re PAC Funding, LLC* (Case No. 08-45371); *In re Palm Beach Finance Holdings, Inc.* (Case No. 08-45392); and also the following case pending in the United States District

Court, District of Minnesota: *USA v. Thomas Petters et al.* (Case No. 08-5348) (collectively known as the “***Petters Litigation***”).

10. During the application period, as reflected on the attachments, Greene Espel supported the Trustee and his counsel with local counsel services, and also acted in furtherance of the Trustee’s efforts (in connection with others) to investigate and take discovery into the existence of and circumstances surrounding any judgment preservation insurance.

11. Greene Espel is seeking compensation in the total amount of \$4,695.00 for services rendered and \$122.76 reimbursement of expenses for the period of time from August 18, 2025 through October 31, 2025.²

12. Greene Espel logged a total of 7 hours at hourly rates ranging from \$655 - \$930 during the time period for which fees were required in this fee application.

13. Greene Espel believes that the requested fees of \$4,695.00 for 7 hours worked, is reasonable considering the nature, extent, and the value of such services, taking into account all relevant factors, including:

The time spent on such services.

14. The transcribed time records and details of services rendered by Mr. Scheiner and his team are attached as Exhibit 4. Applicant has devoted 7 hours in time in providing services to the Trustee between August 18, 2025 through October 31, 2025.

15. All professionals record the time expended in the rendition of professional services for the Trustee by recording a detailed description of such services.

² Notwithstanding the language of the Order, the Trustee’s application (and attached engagement agreement dated August 8, 2025) and that the Applicant was being retained because previous Minnesota-counsel was appointed to a position working for the United States, support the instant request for payment of the Applicant’s fees incurred as of August 18, 2025.

16. All professionals involved in the rendering of services in this proceeding avoided any unnecessary duplication of work and time expended.

The rates charged for such services.

17. The applicant logged a total of 7 hours at hourly rates ranging from \$655 - \$930 during the time period for which fees were required in this fee application. The hourly rate charged are customary fees for services of the type rendered herein.

18. The applicant represents that the fees applied for are in conformity with the fees allowed in similar proceedings for similar services rendered and results obtained. Mr. Scheiner respectfully requests that the Court take notice of the awards which have been made in similar proceedings.

Whether the services were necessary to the administration of, or beneficial at the time at which the service was rendered toward the completion of the case.

19. Nicholas B. Scheiner was retained by the Trustee to assist the Trustee and his other counsel as local counsel in the Petters Litigation and tasks that the Trustee or its counsel may request including, among other things, sponsoring the *pro hac vice* applications of Meland Budwick, P.A., researching specific issues regarding Minnesota law, as well as monitoring pending cases and attending a number of hearings in Minnesota.

20. The services provided by applicant were necessary to the administration of, and beneficial to the estates at the time at which the services were rendered as well as towards the completion of the case.

Whether the services were performed within a reasonable amount of time commensurate with the complexity, importance, and nature of the problem, issue, or task addressed.

21. The applicant submits that the services were performed within a reasonable amount of time commensurate with the complexity, importance, and nature of the problem, issue and tasks addressed.

With respect to a professional person, whether the person is board certified or otherwise has demonstrated skill and experience in the bankruptcy field.

22. Nicholas B. Scheiner is an experienced trial lawyer with a sophisticated understanding of commercial litigation issues and is qualified to perform such services for the benefit of the Liquidating Trustee. Mr. Scheiner received his J.D. from Stanford Law School and is admitted to the Minnesota Bar. He has worked for the Federal Bureau of Investigation. The quality of work performed by the applicant in this proceeding attests to the firm's experience, reputation and ability.

23. Mr. Scheiner submits that the professionals assigned to these cases have the requisite experience, seniority and skills necessary to effectively and efficiently meet the requirements of the tasks required. Applicant believes he has demonstrated the requisite, substantial expertise to skillfully provide his services.

Whether the compensation is reasonable based on the customary compensation charged by comparably skilled practitioners in cases other than cases under title 11.

24. The amount requested by the applicant is reasonable in terms of awards in cases of similar magnitude and complexity. The compensation which Mr. Scheiner is requesting comports with the mandate of the Bankruptcy Code, which directs that services be evaluated in light of comparable services performed in non-bankruptcy cases in the community. The fees requested by the applicant in the amount of \$4,695.00 for 7 hours of services is entirely appropriate.

25. The applicant considers the reasonable value of services rendered to this estate to be not less than \$4,695.00 for services rendered for the Fee Period.

Allocation Between Debtors' Estates

26. The Trustee requests that 18% of the fee awarded be allocated to Palm Beach Finance Partners, L.P. ("PBF") and 82% of the fee awarded be allocated to Palm Beach Finance II, L.P. ("PBF II"). Section 1.76, entitled "Pro Rata Allocation Formula," of the Second Amended Joint Plan of Liquidation dated September 3, 2010 [Dkt No. 245] provides for a *pro rata* allocation formula derived from the Compiled Financial Statements, dated April 30, 2008, for each of the Debtors by Kaufman Rossin & Co. The data contained therein supports an 18%/82% allocation between PBF and PBF II, respectively, based upon the total assets of each entity as of the date of such compilations. Based on the circumstances and since the services provided by applicant were performed on behalf of and benefitted both estates, the Liquidating Trustee believes that this formula is the proper methodology to allocate certain fees and expenses between the two estates and respectfully requests the Court approve the allocation of fees requested in this Application as follows:

Request for Final Approval

27. Pursuant to Article 7.1.11 of the Plan: "The PBF II Liquidating Trust Monitor and the Liquidating Trustee shall, no less frequently than once every four (4) months, submit applications to the Bankruptcy Court for final approval of reimbursement of fees and expenses paid to their professionals."

WHEREFORE, Nicholas B. Scheiner and Green Espel, PLLP, respectfully request allowance of the full compensation and reimbursement of expenses sought under this application as a final award. Mr. Scheiner requests this Court (i) to award a total of \$4,695.00 for fees and \$122.76 costs incurred between August 18, 2025 and October 31, 2025, for a total award of \$4,817.76; (ii) to approve the allocation of fees and expenses between the estates; and (iii) for such other and further relief this Court deems just and proper.

CERTIFICATION

1. I ("*Applicant*") am designated as the professional with responsibility in this case for compliance with the "Guidelines for Fee Applications for Professionals in the Southern District of Florida in Bankruptcy Cases" ("***Guidelines***").

5. In seeking reimbursement for any service provided by a third party, the Applicant is seeking reimbursement only for the amount actually paid by the Applicant to the third party.
