**ORDER GRANTING FIRST INTERIM POST CONFIRMATION APPLICATION FOR
ALLOWANCE AND PAYMENT OF FEES AND EXPENSES TO JOHN H. GENOVESE,
ESQ. AND THE LAW FIRM OF GENOVESE JOBLOVE & BATTISTA, P.A.
[ECF NO. 1375]**

THIS MATTER came before the Court on **September 25, 2012 at 9:30 a.m.** on the First Interim Fee Post Fee Application (the "Application") for Allowance and Payment of Fees and Expenses to John H. Genovese, Esq. and the law firm of Genovese, Joblove & Battista, P.A. ("GJB") as Expert to Chapter 11 Liquidating Trustee, Barry Mukamal (the "Trustee") filed on August 30, 2012 [ECF No. 1375]. In the Application, GJB seeks reimbursement of fees and

expenses incurred from March 27, 2012 through June 30, 2012, in the amount of \$5,348.00 for fees and \$30.85 for expenses, for a total award in the amount of \$5,378.85. The Court, having reviewed the Application, having heard the argument of counsel and being otherwise duly advised in the premises, does hereby

ORDER as follows:

1. The Application is approved.
2. GJB is awarded fees in the amount of \$5,348.00, which amount represents 100% of the interim fees requested in the Application and expenses in the amount of \$30.85, which amount represents 100% of the expenses requested in the Application, for a total award of \$5,378.85.
3. In making the foregoing award, the Court has evaluated the factors set forth in *In re First Colonial Corp.*, 544 F.2d 1291 (5th Cir. 1977) and *Johnson v. Georgia Highway Express, Inc.*, 488 F.2d 714 (5th Cir. 1974), and finds that the amounts awarded herein represent reasonable compensation for actual and necessary services rendered and expenses incurred by GJB.
