**ORDER AWARDING EIGHTH INTERIM POST CONFIRMATION FEE
APPLICATION OF PETER HAGAN AS EXPERT TO THE LIQUIDATING TRUSTEE**

THIS CAUSE came before the Court on January 28, 2014, at 9:30 a.m., upon the Eighth Interim Post Confirmation Fee Application of Peter Hagan as Expert to the Liquidating Trustee [ECF No. 2064] (the "*Application*").

The Court, having reviewed the Application, having heard from all parties in interest who had an opportunity to be heard, having taken into consideration 11 U.S.C. § 331 and each of the

factors that govern the reasonableness of fees as set forth in *In re First Colonial Corp. of America*, 544 F.2d 1291 (5th Cir. 1977) and *Johnson v. Georgia Highway Express*, 488 F.2d 714 (5th Cir. 1974), having heard the argument of counsel, and based on the record, it is

ORDERED that:

1. The Application is **APPROVED**.
2. Peter Hagan, as Expert for the Liquidating Trustee², is awarded compensation in the amount of **\$6,750** (representing 100% of the fees requested) ("**Fee Award**").
3. Pursuant to Section 1.76 of the Plan, and as set forth in the Application, the fees awarded herein are subject to the *pro rata* allocation formula. The Fee Award shall be paid by the particular estate as follows: (a) **\$1,215** in fees from Palm Beach Finance Partners, L.P. and (b) **\$5,535** in fees from Palm Beach Finance II, L.P.
4. Pursuant to Section 7.1.11 of the Plan, the Court ratifies payments previously made by the Liquidating Trustee to Peter Hagan with respect to the Fee Award.
