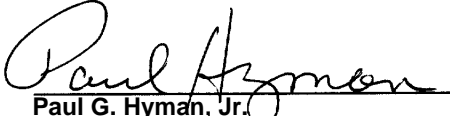

**ORDER GRANTING LIQUIDATING TRUSTEE'S MOTION TO AMEND ORDER  
AUTHORIZING THE EMPLOYMENT AND RETENTION OF CHRISTOPHER  
LAURSEN AND NATIONAL ECONOMIC RESEARCH ASSOCIATES, INC.,  
NUNC PRO TUNC TO SEPTEMBER 13, 2012, AS EXPERTS**

THIS CAUSE came before the Court on September 30, 2014, upon the Liquidating Trustee's *Motion to Amend Order Authorizing the Employment and Retention of Christopher Laursen and National Economic Research Associates, Inc., Nunc Pro Tunc To September 13, 2012, As Experts* [ECF No. 2421] (the "**Motion**")<sup>1</sup>. The Court, having reviewed the Motion and Court file, based upon the representations that Ms. Brown-Hruska (i) is duly qualified, (ii) holds

no interest adverse to the Debtors' estates in the matters upon which she is engaged, (iii) is disinterested as required by 11 U.S.C. § 327(a), (iv) has disclosed any connections with parties set forth in *Fed. R. Bankr. P.* 2014, and (v) her employment is necessary and would be in the best interests of the Debtors' estates and their creditors, it is

**ORDERED** as follows:

1. The Motion is **GRANTED**, *nunc pro tunc* to June 30, 2014.
2. The Employment Order is amended to reflect that the Liquidating Trustee has replaced Christopher Laursen with Sharon Brown-Hruska, pursuant to 11 U.S.C. §§ 327, 330 and 331, and the terms set forth in the Motion, and that any relationship with Christopher Laursen is ceased, *nunc pro tunc* to June 30, 2014.
3. All terms of employment unrelated to Christopher Laursen will remain the same.
