## ORDER GRANTING LIQUIDATING TRUSTEE'S MOTION FOR APPROVAL OF SETTLEMENT SPANISH RIVER CHURCH AND PAYMENT OF CONTINGENCY FEE [ECF NO. 999]

**THIS CAUSE** came before the Court upon the Liquidating Trustee's Motion for Approval of Settlement with Spanish River Church ("SRC") and Payment of Contingency Fee [ECF No. 999] (the "Motion"). <sup>1</sup> The Court, having reviewed the Motion and noting that a Certificate of No Response and Request for Entry of Order has been filed, finds that the notice of the proposed

compromise and settlement is sufficient to comply with Bankruptcy Rules 9019 and 2002(a)(3), Local Rule 9013-1(D) and any other applicable notice requirement, and accordingly, it is:

#### **ORDERED** as follows:

- 1. The Motion is **GRANTED**.
- 2. The Settlement is **APPROVED**.
- 3. SRC shall pay (or cause to be paid) \$6,820.00 (the "Settlement Payment") within 20 days from the date of the entry of this Order. The Settlement Payment may be made via (i) wire transfer pursuant to written instructions to be provided by the Liquidating Trustee or his counsel or (ii) check made payable to "Barry E. Mukamal, Liquidating Trustee" and delivered to Jessica L. Wasserstrom, Esq., Meland Russin & Budwick, P.A., 200 South Biscayne Blvd., Suite 3000, Miami, Florida 33131.
- 4. The Settlement Payment will be allocated and apportioned among the Debtors as follows: 18% to Palm Beach Finance Partners, L.P. and 82% to Palm Beach Finance II, L.P. (the "*Pro Rata Allocation Formula*"), and the wire transfers and/or checks referenced in paragraph 3 above as the mechanism for the Settlement Payment shall be made in the amounts in accordance with this allocation.
- 5. MRB's Contingency Fee in the amount of \$682.00 is approved. The Liquidating Trustee is authorized and directed make payment of the Contingency Fee without the need of further Court Order, in accordance with the Pro Rata Allocation Formula, promptly upon receipt of the Settlement Payment.

- 6. To the extent that SRC has any scheduled claim or proof of interest or has filed a proof of claim or proof of interest in the Debtors' chapter 11 cases, such claim or interest is deemed disallowed in its entirety.
  - 7. The Court retains jurisdiction to enforce the terms of the Settlement.
