**ORDER GRANTING LIQUIDATING TRUSTEE'S MOTION
FOR APPROVAL OF SETTLEMENT WITH REDEEMER BIBLE CHURCH
AND PAYMENT OF CONTINGENCY FEE [ECF NO. 1488]**

THIS CAUSE came before the Court upon the Liquidating Trustee's Motion for Approval of Settlement with Redeemer Bible Church and Payment of Contingency Fee [ECF No. 1488] (the "**Motion**").¹ The Court, having reviewed the Motion and noting that a Certificate of No Response and Request for Entry of Order has been filed, finds that the notice of the proposed compromise and settlement is sufficient to comply with Bankruptcy Rules 9019 and

2002(a)(3), Local Rule 9013-1(D) and any other applicable notice requirement, and accordingly, it is:

ORDERED as follows:

1. The Motion is **GRANTED**.
2. The Stipulation is **APPROVED**.
3. Transferee shall pay (or cause to be paid)) \$35,000.00 (the "***Settlement***

Payment") as follows:

- a) Immediately upon execution of the Stipulation by all Parties, \$7,000.00 will be paid to the Liquidating Trustee (the "***First Payment***");
 - b) Within ninety (90) days from the date the Transferee makes the First Payment, \$7,000.00 will be paid to the Liquidating Trustee (the "***Second Payment***");
 - c) Within ninety (90) days from the date the Transferee makes the Second Payment, \$7,000.00 will be paid to the PCI Trustee (the "***Third Payment***");
 - d) On or before October 1, 2013, \$7,000.00 will be paid to the PCI Trustee; and
 - e) On or before December 31, 2013, \$7,000.00 will be paid to the PCI Trustee.
4. The Liquidating Trustee's portion of the Settlement Payment (\$14,000.00) may be made via (i) wire transfer pursuant to written instructions to be provided by the Liquidating Trustee or his counsel or (ii) check made payable to "Barry E. Mukamal, Liquidating Trustee" and delivered to Jessica L. Wasserstrom, Esq., Meland Russin & Budwick, P.A., 200 South Biscayne Blvd., Suite 3200, Miami, Florida 33131.
 5. The Liquidating Trustee's portion of the Settlement Payment (\$14,000.00) will be held in the trust account of counsel for the Liquidating Trustee pending approval of the Stipulation by the Minnesota Bankruptcy Court.

6. MRB's Contingency Fee in the amount of \$1,400.00 is approved. The Liquidating Trustee is authorized and directed to make payment of the Contingency Fee without the need of further Court Order, in accordance with the Pro Rata Allocation Formula, promptly upon receipt of the Settlement Payment.

7. To the extent that the Transferee has any scheduled claim or proof of interest or has filed a proof of claim or proof of interest in the Debtors' chapter 11 cases, such claim or interest is deemed disallowed in its entirety.

8. The Court retains jurisdiction to enforce the terms of the Settlement.
