**ORDER GRANTING LIQUIDATING TRUSTEE'S MOTION
FOR APPROVAL OF SETTLEMENT WITH DOUG REICH
AND PAYMENT OF CONTINGENCY FEE [ECF NO. 1762]**

THIS CAUSE came before the Court upon the Liquidating Trustee's Motion for Approval of Settlement with Doug Reich and Payment of Contingency Fee [ECF No. 1762] (the "**Motion**"). The Court, having reviewed the Motion and noting that a Certificate of No Response and Request for Entry of Order has been filed, finds that the notice of the proposed compromise and settlement is sufficient to comply with Bankruptcy Rules 9019 and 2002(a)(3), Local Rule 9013-1(D) and any other applicable notice requirement, and accordingly, it is:

ORDERED as follows:

1. The Motion is **GRANTED**.
2. The Settlement is **APPROVED**.
3. Reich shall pay (or cause to be paid) \$74,169.80 (the “*Settlement Payment*”) as

follows:

- A. Mr. Reich shall make the Settlement Payment in twenty (20) monthly payments each in the amount of \$3,708.49 (“*Monthly Installment*”).
 - B. The first Monthly Installment shall be made on June 5, 2013. Thereafter, each Monthly Installment shall be made on or before the fifth day of each calendar month.
4. The Settlement Payment may be made via (i) wire transfer pursuant to written instructions to be provided by the Liquidating Trustee or his counsel or (ii) check made payable to “Barry E. Mukamal, Liquidating Trustee” and delivered to Jonathan S. Feldman, Esq., Meland Russin & Budwick, P.A., 200 South Biscayne Blvd., Suite 3200, Miami, Florida 33131.
 5. To the extent Reich has any scheduled claim or proof of interest or have filed a proof of claim or proof of interest in the PBF I bankruptcy case, such claim or interest is deemed disallowed in its entirety.
 6. The Court retains jurisdiction to enforce the terms of the Settlement.

7. MRB's Contingency Fee is approved and the Liquidating Trustee is authorized to pay the amount of \$370.85 to MRB upon receipt of each Monthly Installment.
