**ORDER GRANTING DEBTORS' EX-PARTE
MOTION FOR JOINT ADMINISTRATION**

THIS MATTER came before the Court upon the *Debtors' Ex-Parte Motion for Joint Administration* (the "Motion") filed by Debtors Palm Beach Finance Partners, L.P. and Palm Beach Finance II, L.P. (collectively, the "Debtors").¹ The Motion requests entry of an order authorizing the joint administration of the bankruptcy cases of the Debtors. The Court finds that (i) it has jurisdiction over the matters raised in the Motion pursuant to 28 U.S.C. §§ 157 and 1334; (ii) this is a core proceeding pursuant to 28 U.S.C. § 157(b)(2); (iii) the relief requested in

the Motion is in the best interests of the Debtors, their estates, and their creditors; (iv) pursuant to Local Rules 1015-1(B)(2) and 9013-1(C)(14), the Court is authorized to grant the Motion without a hearing; (v) upon the record herein after good and sufficient cause existing for the granting of the relief as set forth herein; it is

ORDERED that:

1. The Motion is **GRANTED**.
2. The above-captioned bankruptcy cases are jointly administered for procedural purposes only under Case No. 09-36379-BKC-PGH.
3. The style of these jointly administered cases shall be in the style set forth below:

8. The Court retains jurisdiction with respect to all matters arising from or related to the implementation or interpretation of this Order.
